
1. Head of Committee is authorized to have a team accompanied with him to supervise of the said examination more diligently and transparently.



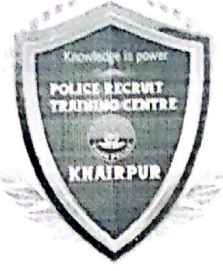
