### **OFFICE MEMORANDUM**

# SUBJECT: SPECIAL INVESTIGATION ALLOWANCE FOR INVESTIGATION OFFICERS OF SINDH POLICE

NO.FD (SR-III) 5-670/2021: With the approval of the Competent Authority i.e. Provincial Cabinet Sindh, the Special Investigation Allowance at the rate of one initial basic of Basic Pay Scale 2022 is hereby sanctioned to the Investigations Officers of Sindh Police, with immediate effect subject to following conditions:

- It shall be admissible to investigation officers (ASIs, Sub-Inspectors, Inspectors, DSPs, SPs/DIGPs/Additional IGP) posted against sanctioned strength borne on heads of accounts/cost centers for establishment of investigation units/offices in Sindh.
- ii. It shall only be admissible to those investigation officers of Sindh Police who deal with the investigation cases and dispose of cases efficiently and timely as per criteria notified by the Home Department in consultation with Sindh Police.
- iii. Only Designated Investigation Officers notified by CCPO office on the recommendation of committee duly notified for the purpose as per detailed SOP.
- iv. Only Certified IOs will be entitled to receive the special allowance upon successful completion of Certification Courses specially designed by Training Branch, Sindh Police.
- v. The Certified IOs will have to investigate "minimum number of cases" in an efficiently and timely manner as per operational guideline issued by the IGP.
- vi. An evaluation report certifying working of IOs will be issued after every three months by Head of Investigation in the District for each investigation Officer receiving Special investigation Allowance.
- vii. The heads of investigation establishment/units/offices i-e Additional IGP/DIG/SP/ (Investigation) shall be competent to withhold/withdraw/recover special Investigation Allowance to eligible police officers for specific period of time on account of poor performance.
- viii. All the heads of Investigation shall ensure that detailed performance criteria and SOP notified by the Home Department in consultation with Sindh Police is implemented in true letter and spirit.
- ix. It shall be payable with effect from the date of issuance of this notification.
- x. Special Investigation Allowance shall not count towards pension and gratuity.
- xi. It shall not be payable during deputation, suspension, EOL and Earned leave beyond 120 days.

xii. Special Investigation Allowance shall not be admissible to the officers who have been made OSDs or who have been directed to report on the charges of inefficiency/misconduct/indiscipline.
